## STOCKBRIDGE MAIN STREET PROGRAM UNVEILS ITS SECOND LITTLE FREE LIBRARY DURING THE 2017 CITY OF STOCKBRIDGE ANNUAL HOLIDAY FESTIVAL

On December 7th, the Stockbridge Main Street Program Advisory Board was joined by the Stockbridge-Jonesboro Alumni Chapter of Kappa Alpha Psi Fraternity, Inc., as they unveiled the City's newest Little Free Library.

This "library" is located in Clark Community Park (111 Davis Road) near the playground area and is a continuance of the Stockbridge Main Street Program's Little Free Library Project. The structure will be assigned GPS coordinates and an official charter number that can be found on both, the official Little Free Library website ([www.littlefreelibrary.org](http://www.littlefreelibrary.org)), and the site's online map. This new book swap location is the second of the planned five locations in and around the historic downtown area. The first was installed at Stockbridge's Reeve's Creek Walking Trail (located at 525 Flippen Road) in April 2017.

The new library's design has a child-friendly



theme and is filled with children's favorites. The library was made possible through a partnership with the Stockbridge-Jonesboro Alumni Chapter of Kappa Alpha Psi Fraternity who donated the funds for the book box, its registration, signage, and some of the first

books. The Main Street Program is also looking to the community for additional donations of new and gently used children's books.

"This project has really taken off," says Kira Harris-Braggs, Stockbridge Main Street Program Manager. "We have been approached by several organizations and businesses who are

interested in helping us place these Little Libraries both around our historic downtown area and in other locations around the city. Though the Main Street Program focuses on the downtown area, anyone can join the Little Free Library movement on their own."

## Q & A STORMWATER MANAGEMENT AND LOW IMPACT DEVELOPMENT (LID)

### Q. WHAT IS STORMWATER AND WHY DO WE NEED TO MANAGE IT?

A. Stormwater runoff is generated when precipitation from rain and snowmelt flows over land or paved surfaces and does not absorb into the ground. As the runoff flows over impervious surfaces such as paved streets, parking lots, and building rooftops, it accumulates debris, chemicals, sediment, or other pollutants. This contributes

to water quality problems if runoff flows directly into surface waterways and is left untreated.

As natural landscapes continue to be converted to urban areas, forests or other naturally vegetated landscapes give way to impervious surfaces. This has led to stormwater runoff becoming one of the largest sources of pollutants to Georgia's surface waters.

In addition, the high flows created by stormwater runoff can cause harm to aquatic habitats. To address these problems, it is critical that jurisdictions adopt new stormwater management practices for urban areas. A recent stormwater management approach involves the use of LID techniques to retain vegetation, limit impervious surfaces, and infiltrate and treat stormwater runoff on-site.

### Q. WHAT IS LID AND WHAT ROLE DOES IT PLAY IN STORMWATER MANAGEMENT?

A. Low Impact Development (LID) refers to a suite of stormwater management and site design approaches that mimic natural drainage processes by retaining vegetation, limiting impervious surfaces, and infiltrating and treating runoff on-site.

### Q. WHAT IS STOCKBRIDGE DOING TO ENSURE THAT STORMWATER IS MANAGED?

A. The City of Stockbridge has adopted guidelines and requirements, better known as stormwater best management practices (BMPs), to help the City meet federal stormwater regulations.
