RESOLUTION NO. - 14-598

A RESOLUTION DEFINING THE BOUNDARIES FOR THE MAIN STREET PROGRAM WITHIN THE CITY OF STOCKBRIDGE; AUTHORIZING THE MAYOR TO EXECUTE ALL DOCUMENTS NECESSARY TO EFFECTUATE THE PURPOSES OF THIS RESOLUTION; AUTHORIZING THE CITY CLERK TO ATTEST SIGNATURES AND AFFIX THE OFFICIAL SEAL OF THE CITY, AS NECESSARY; PROVIDING FOR SEVERABILITY; REPEALING INCONSISTENT RESOLUTIONS; PROVIDING FOR AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

WHEREAS, the City of Stockbridge ("City") is a municipal corporation located within Henry County, Georgia duly organized and existing under the laws of the State of Georgia and is charged with providing public services to residents located within the corporate limits of the City; and

WHEREAS, the Georgia Main Street Program is part of the economic development strategy for the State of Georgia and offers services to affiliated local Main Street Organizations, and

WHEREAS, the Main Street Program is a nationally known successful revitalization strategy with more than 1,800 communities across the country, and

WHEREAS, the Georgia Main Street Program has been authorized to assist commercial areas in cities to develop a public/private effort to revitalize their target areas, and

WHEREAS, the Mayor and Council, on July 25, 2013, approved a resolution of support from the City as part of the application process, and

WHEREAS, the City wishes to move forward with the Main Street Start-up process by creating the Main Street District's boundaries, attached hereto as Exhibit "A" and defined as the area bounded by Lovejoy and Berry Streets on the North, North Henry Boulevard on the South, Burke Street on the West, and East Atlanta Road, including the City Hall Complex, on the East.

**NOW THEREFORE, THE COUNCIL OF THE CITY OF STOCKBRIDGE
HEREBY RESOLVES AS FOLLOWS;**

Section 1. **Approval** - The Mayor and City Council of the City of Stockbridge hereby authorize and approve the boundaries for the Main Street Program, a requirement of the Main Street designation process.

Section 2. **Approval of Execution** - The Mayor is hereby authorized to sign all documents necessary to effectuate this Resolution.

Section 3. **Documents** - The City Clerk is authorized to execute, attest to, and seal any documents which may be necessary to effectuate this Resolution, subject to approval as to form by the City Attorney.

Section 4. **Severability** - To the extent any portion of this Resolution is declared to be invalid, unenforceable, or non-binding, that shall not affect the remaining portions of this Resolution.

Section 5. **Repeal of Conflicting Provisions** - All City resolutions inconsistent with this Resolution are hereby repealed.


Section 6. **Effective Date** - This Resolution shall be effective on the date of its approval by the City Council and Mayor as provided in the City Charter.


