ORDINANCE NO. OB 13-341

AN ORDINANCE TO SET THE CITY COUNCIL REGULAR MEETING DATES, TIMES, AND PLACES FOR 2014; TO REPEAL CONFLICTING ORDINANCES; TO PROVIDE AN EFFECTIVE DATE; AND FOR OTHER PURPOSES

WITNESSETH:

WHEREAS, the City of Stockbridge ("City") is a municipal corporation duly organized and existing under the laws of the State of Georgia and is charged with providing public services to residents located within the corporate limits of the City; and

WHEREAS, Section 3.13 (a) of the City Charter states that the City Council shall hold regular meetings at such times and places as prescribed by ordinance; and

WHEREAS, the City has not yet set the dates, times, and places of its regular meetings of its City Council for 2014; and

WHEREAS, the City Council desires to set the dates, times, and places of its regular meetings for 2014 in order to notify its citizens so that they can make plans to attend such meetings should they desire to do so; and

WHEREAS, the Mayor and City Council of the City of Stockbridge, Georgia, in the exercise of their sound judgment and discretion, after giving thorough thought to all implications involved, and keeping in mind the public interest and welfare of the citizens of the City, have determined it to be in the best interest of the citizens of the City that this ordinance be adopted in order to set forth the dates, times, and places of regular City Council meetings in 2014 pursuant to Section 3.13 (a) of the City Charter.

THEREFORE, THE CITY COUNCIL OF THE CITY OF STOCKBRIDGE HEREBY ORDAINS:

SECTION 1. Adoption of Dates, Times, and Places of 2014 City Council Regular Meetings.

Pursuant to Section 3.13 (a) of the City Charter, the City Council for the City of Stockbridge hereby sets the dates and times for its regular meetings for 2014 as listed in the attached Exhibit "A," which document is incorporated herein by reference. All such Council Meetings shall be held in Council Chambers and all such Council Work Sessions shall be held in the Work Session Room, City Hall, Stockbridge, Georgia, unless changed by ordinance of the City Council and properly noticed as required by Georgia law.

SECTION 2. Approval of Execution. The Mayor is hereby authorized to sign all documents necessary to effectuate this Ordinance.

SECTION 3. Attestation. The City Clerk is authorized to execute, attest to, and seal any documents which may be necessary to effectuate this ordinance, subject to approval as to form by the City Attorney.

SECTION 4. Codification and Severability.

(a) It is hereby declared to be the intention of the City Council that all sections, paragraphs, sentences, clauses and phrases of this Ordinance are and were upon their enactment believed by the City Council to be fully valid, enforceable and constitutional.

(b) It is hereby declared to be the intention of the City Council that to the greatest extent allowed by law each and every section, paragraph, sentence, clause or phrase of this ordinance is severable from every other section, paragraph, sentence, clause or phrase of this ordinance. It is hereby further declared to be the intention of the City Council that to the greatest extent allowed by law no section, paragraph, sentence, clause or phrase of this ordinance is mutually dependent upon any other section, paragraph, sentence, clause or phrase of this ordinance.

(c) In the event that any section, paragraph, sentence, clause or phrase of this ordinance shall, for any reason whatsoever, be declared invalid, unconstitutional or otherwise unenforceable by the valid judgment or decree of any court of competent jurisdiction, it is the express intent of the City Council that such invalidity, unconstitutionality or unenforceability shall, to the greatest extent allowed by law, not render invalid, unconstitutional or otherwise unenforceable any of the remaining sections, paragraphs, sentences, clauses, or phrases of the ordinance and that to the greatest extent allowed by law all remaining Sections, paragraphs, sentences, clauses, or phrases of the ordinance shall remain valid, constitutional, enforceable, and of full force and effect.

SECTION 5. Repeal of Conflicting Provisions. Except as otherwise provided herein, all ordinances or parts of ordinances in conflict with this ordinance are hereby repealed.

SECTION 6. Effective Date. This ordinance shall become effective immediately upon its adoption by the Mayor and City Council of the City of Stockbridge as provided in the City Charter.
